Beyond the Oral Sessions and Poster presentations, the meeting holds Research Group-sponsored Symposia, advocacy events, a three-part Distinguished Lecture Series, and countless networking opportunities and events.

We invite you to start your meeting experience at the Opening Ceremonies and Welcome Reception on Wednesday, July 14. This event will allow you to celebrate award winners and network with fellow attendees. Thursday through Saturday will feature a superior Exhibit Hall with corporate, educational and non-profit industry representatives, eager to share their innovations, products and services with you. When and how can I register?

Registration is now open. [Click here](#) to register online. You may also download the registration application from our [Web site](#) and mail or fax with the appropriate payment.

NOTE: If you FAX your registration form or complete the form on the Internet, DO NOT mail the original, or you may be registered and billed twice.

What are the rates for registration?

Any person with an interest in dental research—including all presenters, co-authors, and current and past IADR/AADR members—is required to pay the appropriate registration fee. Member, non-member and student registration fees include all sessions, admission to the exhibition, and a copy of the final Program and a USB of Abstracts.

As of March 30, 2010, all registrations will be charged 8% Value Added Tax (VAT). The Spanish VAT is 8% of the total registration amount due. The Spanish VAT is not kept by IADR but is a tax required by and will be forwarded to the Spanish government. IADR must add 8% to the total of your meeting registration and all events selected.

All registration and event fees are stated net of any taxes that may be due. IADR is required to charge Spanish VAT to all attendees, with the exception of any attendees who are themselves registered for Spanish VAT and who are able to prove this to the satisfaction of IADR. Where applicable, 8% Spanish VAT will therefore be invoiced in addition to the net registration and event fees stated and will be payable to the IADR at the same time. Some attendees may be eligible to obtain a refund of this Spanish VAT from the Spanish government by submitting a valid claim within the statutory deadline (subject to reciprocity agreements between Spain and the [claimant's country](#)). Further information can be obtained from the Spanish tax authorities or by contacting a VAT reclaim agency. Although IADR does not endorse any single agency, IADR has retained the services of Meridian Global Services (www.meridianglobalservices.com) for VAT recovery.

IADR has updated the [online registration](#) and [PDF registration form](#) to include the Spanish VAT. Older versions of the registration form that do not include the Spanish VAT information will not be accepted. IADR needs to collect an 8% Spanish VAT for all meeting registrations and events and reserves the right to charge the correct amount to registration forms that do not account for the Spanish VAT. You may [register online](#) for the meeting if you are paying with a credit card.

Payment must be received at the time of registration. If no money is received with the form, you will be charged the additional \$100 for member or non-member registration regardless of when the form was received. Registration forms received via fax or the Internet are accepted for individuals paying by credit card only (American Express, MasterCard, or VISA only).

Registration Categories

Member or Student Member

To register as a Member or Student Member, you must have **activated or renewed your 2010 membership by the time you register for the meeting.** If you wish to join the Association to take

advantage of the lower membership registration fee, please submit your application form with your registration form. More information regarding membership, including a list of benefits and an application, [is available online](#). If you are registering online and your membership has not yet been renewed for 2010, you will be required to pay the membership dues before completing your online registration at the member rate. If your original payment was by check, you will receive an invoice with a balance due for this meeting. The balance due must be paid on site before you can receive your badge.

Student Non-member

To register as a Student Non-member, you must be enrolled full-time in a recognized academic institution, may not hold an academic appointment, and must send proof of student status (a letter from an advisor or dean) with the registration form. A student verification form is available online at http://www.iadr.org/files/public/2010_StudentVerif.pdf.

NOTE: Non-member students registering on site must bring proof of student status. Those pre-registering must mail the information with the registration form.

Retired Member

To register as a Retired Member, you must have been verified as retired from full-time employment and must have paid IADR/AADR dues for 25 consecutive years. Retired non-members must pay the full non-member registration fee.

Accompanying Persons

Accompanying persons are non-dentists, non-researchers, non-IADR/AADR members who may be traveling to Washington, DC with a meeting delegate and who have no scientific or educational interest in the meeting. Meeting delegates' students, lab technicians, colleagues, past IADR/AADR members, co-authors, etc., do not qualify as accompanying persons and are required to pay the appropriate registration fee if they wish to attend.

If your accompanying person wishes to hear your presentation, he or she must register and pay the \$50 fee (plus 8% VAT \$4.00, \$54.00 total) and receive a special color-coded badge-holder on site. The badge-holder will admit an accompanying person to one session only and will not be honored at any other time during the meeting. Anyone who wishes to attend more than one session is considered to have more than a "personal" interest in dental research and will be required to pay the appropriate fee. Should you register in the wrong category, IADR has the right to charge your credit card the difference in registration fees.

Exhibitors

Each commercial exhibiting company is entitled to receive four (4) complimentary meeting registrations per paid booth. Each educational exhibiting company is entitled to receive one complimentary meeting registration per paid booth. It is the responsibility of the exhibiting company to use the complimentary registrations, either by submitting the EXHIBITOR Pre-registration Form (which will be sent to the contact person listed on the exhibit application) prior to May 28, 2010, or by using the complimentary registration on site. Check with your exhibit contact person to see if you will be one of the complimentary registrants for your company BEFORE you register. If you are not a complimentary exhibit registrant, please use the attached Pre-registration Form and pay the appropriate registration fee. I am a presenter. Do I need to register?

YES! All presenters are REQUIRED to pre-register for the meeting by **May 14, 2010**. If a presenter is not pre-registered by the deadline date, his/her abstract will be withdrawn from the General Session and will not be printed in the final Program Book. The abstract will also not be citable as part of the Special Issue of the *Journal of Dental Research*.

If I pre-register, when will I receive my confirmation and registration information?

Pre-registration is strongly advised. Registration forms received after the deadline date may not be processed and will be charged the on-site registration fee. If an e-mail address is supplied, delegates will receive a

confirmation letter via e-mail; otherwise your confirmation will be sent via fax or mail. You will receive a confirmation of registration prior to departing for the meeting. If you pre-register and do not receive a confirmation, please bring a copy of your registration form and proof of payment to the registration desk on site.

The Pre-registration deadline is May 28, 2010. Persons registering by this date will receive their registration materials in the mail prior to the meeting. Those registering after that date can pick up their materials on site. However, a registration confirmation will be sent as soon as all forms are processed.

I didn't receive my pre-registration materials. What should I do?

Contact IADR Registration at registration@iadr.org or by phone at +1.703.548.0066 from 9 a.m. to 5 p.m. EST, Monday through Friday. If you did not receive your pre-registration materials in the mail, they will be available for you to pick up on site at the meeting.

What if I forget or misplace my badge?

A \$25.00 fee (plus 8% VAT, \$27.00 total) will be charged for all registration badge reprints requested on site. You will also be required to show identification to request a badge reprint.

What is the meeting cancellation/refund policy?

Requests for refunds for registration must be received in writing by the deadline date. Refunds or credits will not be given for failure to attend, late arrival, unattended events or early departure. Refunds will be processed 6-8 weeks after the meeting. Refunds due to an error by the IADR will be processed immediately and in full.

If you are unable to attend the meeting because you were denied a visa, you will be granted a refund only if you submit a copy of your visa rejection letter and proof that you applied for a visa no later than May 1, 2010. Non-presenters are encouraged to apply for a visa as soon as possible, but also no later than May 1, 2010. If you meet these conditions, a refund will be issued less the cancellation fee above. Valid requests for refunds due to visa problems must be received in writing no later than 15 days after the meeting.

NOTES: If you need to cancel your Lunch & Learning program and/or accompanying person registration, a full refund is available until May 28, 2010. After that date, no refund is available.

If a refund is requested for both meeting registration and membership dues, both the registration cancellation fee and the membership dues refund processing fees will be withheld.

When and how can I book housing?

How do I get an invitation letter necessary to obtain a visa?

You can request a copy online when registering or on your print registration form. If you have already registered and need to get a copy, you may request a copy by e-mailing IADR Registration at registration@iadr.org or by phone at +1.703.548.0066 from 9 a.m. to 5 p.m. EST, Monday through Friday. Please be sure to have the following information available: date of birth, nationality, and passport number.

NOTE: An invitation is not a commitment on the part of IADR to provide any financial support, nor is it a guarantee of the acceptance of your abstract.

Visa Requirements

It is never too early to start working on getting your visa. It can take many weeks to get a visa to enter Spain. Each Spanish Consulate has different visa application procedures, so you must call the consulate that has jurisdiction over your state of permanent residence to find out which procedures apply. Visitors to Barcelona must hold a passport that is valid for at least six months AFTER their planned departure date.

Citizens of the European Union do not require a visa for Spain.

Non-EU citizens visiting Spain need a visa to enter and visit Spain, unless there exists a special agreement between Spain and your home country. These countries are those of North & South America in addition to: Andorra, Australia, Brunei, Costa Rica, Croatia, Cyprus, the Czech Republic, Estonia, Gibraltar, Grenada, Hungary, Iceland, Israel, Japan, South Korea, Latvia, Lithuania, Malaysia, Malta, Monaco, New Zealand, Norway, Poland, San Marino, Singapore, Slovakia and Switzerland.

If you are one of these nationalities, you can enter Spain without a visa and stay for up to 90 days in any six-month period. Please visit www.maec.es and click on Consulate Services for more details.

What airport services Barcelona and what are the ground transportation options?

Two major airports serve Barcelona: Barcelona International Airport (BCN) and Girona International Airport (GRO).

Abstract notifications will begin on April 16, 2010.

What size is the poster board for poster presentations?

Dimensions of the poster board are .92m WIDE x 2.2m HIGH. The board will be used VERTICALLY and NOT HORIZONTALLY.

Please make sure to include your Presentation # in the top right corner in your poster materials (make it large enough to make it easy for people to find your presentation as they are walking down the aisles).

What is the dress code?

Due to the weather in Spain in July, the dress code for this meeting will be business casual.

What hotel(s) are within walking distance of the convention center?

The Hilton Diagonal Mar (HQ Hotel), AC Barcelona, Barcelona Princess and Diagonal Zero are less than a minute's walking distance from the convention center. All other hotels in the convention center area are about a 10-20 minute walk or a short metro or tram ride away. Hotels located in the Olympic Marina area are a 15 minute metro or tram ride, and city center hotels have a 20 minute commute.
